#### PHBS Holds 2016 Peking University Global Financial Forum

With the theme of "China's Financial Integration into the World," the 2016 Peking University Global Financial Forum was held at the Peking University HSBC Business school October 29. Co-hosted by the Union of Finance Alumni of Peking University and PHBS, the annual conference this year featured five keynote speeches, four sub-forums and a dialogue with Nobel Laureate Thomas Sargent. Over 1000 scholars, policymakers and practitioners worldwide converged to discuss Chinese economic issues, the financial market, and exchange rates, among other topics. Distinguished guests attended the conference and made speeches, including Thomas Sargent, 2011 Nobel Laureate in economics; Markus Rodlauer, deputy director of the IMF Asia-Pacific Division Markus; Laura Cha, chairman of the Financial Services Development Council (FSDC, Hong Kong), Yu Yongding, fellow of the Chinese Academy of Social Sciences and president of the China Society of World Economics (CSWE); Fan Gang, PHBS professor and member of the Monetary Policy Committee of the People's Bank of China, etc.
