Chinese Corporate Innovation Report Released

Produced by PHBS and sponsored by HSBC China, the Chinese Corporate Innovation Report focusing on the influence of corporate innovation was recently released. The report sampled 2,534 enterprises including listed companies and the leading enterprises in manufacturing. The report evaluates multiple dimensions of the current situation and future Chinese enterprises' innovation trends and development.

Professor Wen Hai prefaced the report, and Professors Shusong Ba, Wei Chen and Geng Xiao provided comments. The report was written by Professor Ting Ren and Post-Doctoral fellows Jianzhang Wei, Xuemin Liu and Lijun Pang. More...

Market Report Series Released Promoting Integrated Development of the Greater Bay Area through REITs Construction

To more deeply analyze the important role of real estate investment trusts (REITs) in the real economy and promoting resource sharing and industrial integration in the Greater Bay Area, SCGE Realty Capital and the Enterprise Development Institute of PHBS have jointly created a series of reports on the construction of the REITs market since 2019. **Professor Wen Hai** and Zewang Ni, chairman of Shenzhen Capital Group, serve as editorial board directors; **Professors Shusong Ba, Geng Xiao, Ting Ren** and others serve as board members. Two reports were recently released, respectively, *REITs Market Development in the Greater Bay Area (2020)* (translated from Chinese) and *It's Time to Develop the Public REITs Market* (translated from Chinese). PHBS Releases Macroeconomic Monthly Forecast

The PKU Research Center for Macroeconomy and Finance (CMF) released the *PHBS Macroeconomic Monthly Forecast* in its May issue. The report points out that as the domestic COVID-19 pandemic has been controlled, economic activities such as production and consumption are gradually recovering in China. Yet, the overseas epidemic has severely impacted the economies of many countries, causing a sharp decline in external demand, which will continue to affect foreign trade companies and related industry chains, as well as slowing the growth of China's imports and exports. CMF publishes monthly analysis and forecasts for China's major macroeconomic indicators released by CMF. **Professor Wen Hai** serves as the director of CMF, and the chief adviser is **Professor Thomas Sargent**, the 2011 Nobel laureate in Economics.
