HSBC Financial Research Institute at Peking University (HFRI) Cataloged in Chinese Think Tank Index (CTTI)

The HSBC Financial Research Institute (HFRI) has been included in an important database, the CTTI Source Think Tank Index. The directory was released on December 19 during the Nanjing University and Guangming Daily 2019 China Think Tank Governance cum Theoretical Dissemination Summit Forum in Beijing. CTTI is a think tank data management and evaluation system developed by Nanjing University's China Think Tank Research and Evaluation Center and the Guangming Daily Think Tank Research and Publishing Center. It is currently the largest think tank vertical search engine and data management platform with complete intellectual property rights in China. HFRI was founded in December 2008 to facilitate communication among international and domestic universities, financial research institutions, and financial scholars and to provide an open academic and policy communication platform.
