## PHBS Holds the 5th AEARU Development and Collaboration of Asian Business Schools Workshop

With the theme of "Business Education: Meeting the Challenge of Innovation," the 5th AEARU Development and Collaboration of Asian Business School Workshop was held at the Peking University HSBC Business School (PHBS), October 22 to 23. The Association of East Asian Research Universities (AEARU), founded in 1996, is a regional organization aiming to enhance academic exchange between leading universities and contribute to economic and social progress in the region. This year's workshop featured keynote speeches and five plenary panels. Business schools' deans and leading entrepreneurs converged to engage in open discussions on trends of business school education to meet the market demand of innovation and entrepreneurship. It also provided students from AEARU member universities a venue for presenting their academic achievements. On the second day of the conference, participants visited Tencent.
