## **MBA Part-time Programme**

The MBA programme is completely taught in English, MSc and LL.M. programmes have only 20% in English.

We recommend selected weeklong courses of the MBA which include: »Managerial Effectiveness«, »Dealing with Informational Complexity«, »Innovation Management«, »Corporate Social Responsibility Project«, and »Germany's *Mittelstand* Companies: Managing SMEs in the Heart of Europe« (<u>International Summer Academy</u>) Some elective courses may not be offered every year. They are mostly offered in the first half of the year between February and July.

## **Grading and Credit System**

GGS MBA courses are worth 6 ECTS credits with 48 contact hours.

#### **Marking Scale**

The final mark will be expressed on a scale from 0 to 50 points where 50 is the best and 0 the worst possible grade. 14 points and below constitute a failing grade.

## How the Admission Process Works

The student selection process is to be conducted first by the home institutions of incoming students. Each exchange partner can nominate up to the number of students agreed upon by the partners. Nominations should be made by email to Constanze Wagenblast containing the students' name, desired module, gender, date of birth, nationality and email address.

After exchange partner schools have nominated students, students will receive instructions and should fill out the application form.

We do not require the submission of a TOEFL or IELTS, but we expect that the home university will ensure their students have an English level equivalent to an 87 TOEFL iBT or a 6.5 IELTS, Proof of Level B2 English language proficiency (Common European Framework).

Students should have at least 2 years of work experience.

Exchange Application Deadline: Three months prior to the module.

## **Pre-Arrival**

#### Visa Documentation

GGS will cooperate with incoming exchange students to arrange for the appropriate documentation. Students will be responsible for researching the specific application requirements for their country. Additional visa information is available at the website of the German Ministry of Foreign Affairs.

#### Health Insurance Coverage

All exchange students must have sufficient health insurance to cover them during their time in Germany. Students may have insurance from their own local insurance provider or they may purchase short term insurance. At a minimum, students will be expected to have medical insurance from their home country that provides international coverage in case of hospitalization. International student insurance that includes medical evacuation and repatriation is also recommended.

#### Housing

There is no dormitory complex on campus, there are hotels nearby. GGS cooperates with different hotels and has special rates (>  $\leq$  56.00 for a single room). GGS can also provide accommodation in shared apartments ( $\leq$  370.00 per month).

#### Dining

There is a cafeteria on campus and many restaurants around.

#### Costs:

Exchange students do not have to pay tuition fees. There might be a course fee (€895) as in the case of the International Summer Academy. It covers then all programme events and accommodation in a standard hotel, meals, and local transportation. The International Summer Academy is complemented by social and cultural programme for students once a year in July. Exchange students will have additional opportunities to travel individually during the academic year.


Students are always expected to cover their own way to and from Heilbronn, Germany.

The city of Heilbronn (population 125,437) is the hub of the Heilbronn-Franken region in the state of Baden-Württemberg in southwestern Germany. Principal industries are metalworking (cars and car parts, machine and tool construction), electronics, food and luxury foods, paper and printing, chemicals, and salt mining. The region is home to the headquarters of several wholesale and discount retail companies.
