2.2 Course specific objectives

This course aims to equip students to understand and engage in fundamental theories and empirical research in the field of economic development, with a focus on China and other selected countries. Learning will be achieved through reading book chapters, presenting academic papers and articles, and critically analysing the learning materials.

2.3 Assessment/Grading Details

Students are expected to attend all lectures, participate in class discussions, read the required class materials and complete projects. The course grade will be determined by:

- [1] Attendance and class participation (5%). Attendance to all lectures is mandatory.
- [2] Class presentation (25%). Students will present papers from the reading list.
- [3] Midterm exam (30%). Midterm exam includes problem solving and essay questions.
- [4] Final project (40%). There will be a final project related to the topics in the lectures.

2.4 Academic Honesty and Plagiarism
