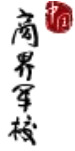

1. Course Description

1.1 Context

This course is designed to provide you with an overview of the major theories and approaches to the study of mass communication. These include social scientific studies of media effects, and the normative assumptions and expectations shaping media production and regulation. In addition to functioning as a “sampler platter” of these types of theories, this course will examine the context in which these approaches developed, the ways in which they are evaluated, and their impact on the field of communication. Students are expected to finish assigned readings before class to make sure you are ready to ask questions, agree, disagree, share relevant cases and experiences, as well as provide your own points of view.

1.2 Textbooks and Reading Materials

There is no required textbook for this course. Readings will be posted to CMS. Course reading materials are from different disciplines including communication, advertising, and marketing, among others.

- The impact of these theories and approaches on the ways in which media and audiences are constructed.
- The usefulness of "mass" communication theory in a world of the internet & social media.
