PKU Shenzhen Forum 2024 Held in Shenzhen

On March 30, the Peking University Shenzhen Forum 2024 was held at Wuzhou Guest House, with the theme "Technology Creates the Future, Reform Leads Development." More than 1,000 experts, scholars, and officials from the fields of economics, finance, technology, and international relations attended the event. **Professor Wen Hai**, Vice Chairman of Peking University Council (former Vice President) and Founding Dean of PHBS, presided over the forum. Professor Jin Zhang, Vice President of Peking University, delivered the opening remarks. Distinguished keynote speakers included Chunli Bai, Honorary Chairman of the Presidium of the Academic Divisions of the Chinese Academy of Sciences; Gang Yi, Chairman of the China Finance Council and Former Governor of the People's Bank of China; Liqun Jin, President and Chairman of the Board of Directors of the Asian Infrastructure Investment Bank (AIIB); Professor Qingguo Jia, Member of the Standing Committee of the 14th National Committee of the Chinese People's Political Consultative Conference, and Professor Qiren Zhou at the National School of Development at Peking University. **More...**
